4. Details of our assessment

Unannounced site inspection undertaken by Michael Edwards and Sally Wakeford of Natural Resources Wales accompanied by site manager Neil Rickard of Briton Ferry Shipping Services.

Under **condition 1.1.1** The operator shall manage and operate the activities: (a) in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attention of the operator as a result of complaints. During the inspection the site operated in a manner described in the submitted environmental management system in line with **condition 1.1.1a**, this document and the environmental permit were available on request as required under **conditions 1.1.2 and 1.1.3**. It was also confirmed by the site that Dr Tony Davies acts as the Technically Competent Manager in line with **condition 1.1.4**.

2.2.1 The activities shall not extend beyond the site, being the land shown edged in green on the site plan at schedule 7 to this permit. All wastes on site were stored within buildings on impermeable surfaces and within the boundary of the permitted area.

Condition 4.2.2 requires waste returns to be submitted quarterly, since the inspection a review of the returns submitted for 2021 and found potential issue with a waste that has been accepted onto site under the European Waste Catalogue (EWC) code 16 11 04 which was recorded in the submitted returns for Q1 of 2021. This waste is not listed in Schedule 2 of the environmental permit.
