### Emissions to Air

Monitoring data for emissions to air for particulate matter from emissions points A2, A5, A7 and

A10. A11 for VOC.

Noted that all emissions are below specified ELVs.

Although not subject to specified ELVs, monitoring data for the following substances/parameters has not been provided: Thallium, Gallium, Selenium and Arsenic (A2, A5, A7, A10 combined).

Breach of permit condition 4.1.2 (G4-CCS4)

Condition 4.1.2 requires that the operator shall, unless otherwise agreed in writing, submit reports of the monitoring and assessment carried out in accordance with the conditions of this permit
