4. Details of our assessment

Tony Bruten attended with Peter Jones both officers from Monmouthshire & Torfaen Environment Team.

This was a routine site permit inspection but as this year units had to submit a record of compliance with their BAT conclusions the inspection focussed on the returns received by NRW during March 2021. A copy of these returns are attached to the permitting file and had to be submitted to conform with permit requirements.

The returns covered BAT 1-15, 19, 23-27, 29 & 32.

TB and PJ discussed each BAT conclusion and the information supplied by Portfield and were satisfied that they were all correct and being complied with.

Both officers were then escorted around the site by Julian Williams who explained that the next batch of broilers would be the last they were having at this unit and following that batch the premises was going back to the owner who would then continue to run the site.

There were no obvious issues with the site but there may be some requirement for upgrading of concrete surfaces by the owner especially where drainage was carrying dirty or clean water.

Tony Bruten can be contacted by the new owner to discuss.

There were no breaches identified.
