### 4. Details of our assessment

Officers met the Area Manager, Site Manager and Landfill Gas Manager. These members of staff accompanied officers around the site.

Officers observed some mud staining near the site entrance and on the road adjacent to the site. This was discussed with the Area Manager who explained that they had hired a road sweeper to clean the roads earlier in the day and it was also scheduled to clean them later in the afternoon. The operator continues to ensure vehicles use the Hippo Wash before leaving site.

There was a very slight landfill gas odour detected on site. This odour could not be detected by officers during an offsite odour assessment completed immediately after the site inspection. This offsite odour assessment included the following areas: Newhall Road, Vauxhall industrial estate, Heol estate and Bangor Road.

During March/ April 2020, an area of 5,500m<sup>2</sup> was permanently capped with clay on the outer flank of Cells 3 and 4. This area has recently been covered with restoration soils. The site is currently importing and stockpiling more soils for the next phase of capping.

The waste levels within the southern boundary of Cell 4 are still being brought up to final height and clay capping works for this area are scheduled for Spring 2021 when weather and ground conditions are more favourable.
