4. Details of our assessment

NRW officers Phil Harper and Donna Muirhead visited OJ Jones, Land at Gelert Ltd, Ffordd Penamser, Porthmadog, Gwynedd, LL49 9SL on the 7th May 2021 at 11:30 am. Dewi Jones accompanied the site visit. This was a pre-arranged site which was conducted due to a report of dust being blown from the site into residential areas.

At the time of the visit weather conditions were showery and overcast.

At the time of the visit there was no activity on site.

B3 Site Drainage

Site drainage ditches were free from obstruction and clear.

C4 Containment of Stored Materials

Waste returns show that 1700 tonnes of waste were accepted by the site in the last quarter. Waste was stockpiled on site waiting to be processed. Waste stockpiles were segregated from stockpiles of product.

F1 Odour

No odours on site or outside of the site boundary.

F2 Noise

Site was operational during the inspection, no excessive noise.

F3Dust/fibres/particulates and litter

Ground conditions were damp at the time of the inspection. No dust on site, no litter outside of the site boundary.

F4 Pests/birds and scavengers

No vermin on site.

F5 Deposits on road

No deposits or mud on the road outside the site.

A visit to the site office to inspect paperwork was not conducted due to the COVID-19 pandemic.

Advice and Guidance

Natural Resources Wales has received a report stating that dust is being blown into residential areas that are local to the site during dry weather. Due to weather conditions no dust was generated by the site on the day of the inspection. However, dust suppression methods were discussed. Please provide an updated Environmental Management System which addresses dust management and suppression and implement by **Monday 2nd August 2021**. Please send updated EMS to Natural Resources Wales by this date.

Please be advised that:

-The failure to control dust from a permitted site is an offence under the Environmental Permitting Regulations 2016.

-The failure to control dust from business premises, including the exempt area which is adjacent but connected to the permitted area is an offence under Environmental Protection Act 1990.
