Emissions

- a. Q1 2021 BH9 Ammonia (N2) 3-point moving average 1.3 mg/l*
- b. Q1 2021 BH1 Zinc 3-point moving average 0.1 mg/l*
- c. Q1 2021 BH9 Zinc 3-point moving average 0.73 mg/l*
- d. Q1 2021 BH10 Zinc 3-point moving average 0.18 mg/l*
- e. Q1 2021 BH9 Nickel 3-point moving average 0.04 mg/l*

Ammonia limit is 1 mg/l

Zinc limit is 0.04 mg/l

Nickel limit is 0.01 mg/l

Not known whether emissions are from historic landfill and/or reclamation/construction materials. Approved revised HRA, suggestions to increase trigger levels.

Tata will need to submit permit variation to increase trigger levels. Previous discussions by previous officers with Tata, states this will be done upon completion of revised gas monitoring.

Gas Monitoring

External wells data showing elevated levels of CO2 against ELV. CO2 limit of 1.5% v/v

- a. Feb 2021 BH1 CO2 level 1.6 % v/v
- b. Mar 2021 BH1 CO2 level 1.8 % v/v
- c. Jan 2021 BH8 CO2 level 1.6 % v/v
- d. Feb 2021 BH8 CO2 level 2.0 % v/v
- e. Mar 2021 BH8 CO2 level 1.8 % v/v

All CO2 readings show a breach of limit.

The existing borehole locations have increases in naturally occurring gases, this may be due to the marsh and/or tidal effects. Therefore, it is not known whether source is anthropogenic or from surrounding marshland, no score given for breach.

In waste leachate wells showing elevated CO2:- L6 Max 4.5% L1 Max 1.8%

Waste Received into landfill was 15.84 tonnes of Inert Construction Waste. No Waste removed.

ACTION

Need to check whether this has taken place as it seems to still be an issue in relation to their monitoring results.

Tata need to consider application for increasing trigger levels to remove the frequent minor breaches occurring, whilst investigating potential root cause.
