4. Details of our assessment

This CAR Form is issued in regards to a non-compliance of Permit Condition 2.1.1 - Permitted Activities -

2.1.1. The only activity authorised by the permit is the activity specified in schedule 1 table S1.1 (Discharge of storm sewage via POINT OF DISCHARGE).

On the 27th of April NRW received a report of pollution to the Afon Goedol at Tanygrisiau. The pollution was reported to discolour the river and had a sewage smell. NRW subsequently sent a POLLFAX to DCWW.

NRW then received a WATPOL from DCWW (Sap Ref 95588487) on the 28th of April confirming that the discoloration was the result of the overflowing CSO at Penycefn (CG0186001).

Over subsequent WATPOL's it was explained to NRW that there are long standing access issues at the site which prevent DCWW from carrying out regular maintenance of the CSO. The build up of silt, rags and wipes within the CSO were confirmed by DCWW to be the cause of the discharge and pollution incident.

Seeing as the permitted discharge for the CSO is for 'Storm discharge' only, the discharge on the 27th of April can be considered as an unpermitted discharge.

We are aware that there is an OPNOT's in place for the existing situation (314909096), with the initial OPNOT dated the 15/10/2018.

NRW would like to request that DCWW submit a plan to NRW of how this issue will be resolved, and how long term maintenance of the CSO can be assured as future incidents of this nature are foreseeable.
