4. Details of our assessment

A report in response to Improvement Conditions IC5 & IC6, '*Updated Site Characterisation and Baseline Report, Padeswood Cement Works*', was received on 13/08/20.

Condition 2.4.1 required this improvement Condition to be completed by 31/03/18. **NRW considers this a breach of Permit (G4 Reporting & Notifications to NRW - C4 no environmental impact). ACTION 1: The Operator should review their Environmental Management System (EMS) to ensure reporting requirements such as Improvement Conditions are reviewed and noted when Permit is varied. Please provide a summary of the review in writing to NRW by 10/09/21.**

NRW have reviewed the report and in general the reports are and the proposed soil and groundwater monitoring is appropriate. However, we have concerns over 2 landfills which we consider to overlap the installation boundary as follows:

1) In the South, permit EAEPR\EA/EPR/BP3594FN/A001 (red hatching Envirocheck map). The report says it is outside the installation permitted boundary. We disagree from overlaying maps. From the report submitted various site investigations have been undertaken on the landfill to the south, therefore any relevant information on ground conditions and concentrations of contaminants should be included within the site condition report, it is likely that enough site investigation/baseline data is already available.

2) In the North East, an historic landfill (EAHLD14734) (solid red below Envirocheck map) to the northeast, which again overlaps the permit boundary. The report does not mention this landfill at all. With regards to the landfill to the northeast this also should be included in the conceptual model in the SCR, and whilst it is possibly not necessary (depending on the consultants assessment) to take samples now, this landfill area could/should be included in the schedule for future monitoring.

ACTION 2: As these landfills are within the boundary they should be included in the Site Condition Report with sufficient baseline data to characterise the soil and groundwater in the landfill areas. Please revise the Site Condition Report including the landfills in the conceptual model and any relevant baseline data and re-submit by 10/12/21.
