### Review of quarterly monitoring returns

Condition 4.2.3 requires that a report on emissions over the previous quarter shall be submitted within 28 days of the end of the reporting period. Quarter 1 (January – March 2021) returns were received on 22 April 2021.

Monitoring was undertaken in accordance with Condition 3.5.1.

Emissions to sewer January – March 2021 - no issues with data.

Efficacy data submitted shows pass for all months in Q1 2021.
