4. Details of our assessment

As a part of Natural Resources Wales' (NRW) routine assessments for compliance the

waste returns for Rhydeionon were reviewed.

G4 Reporting and notification to Natural Resources Wales - Cat 4

During the review of the waste returns on the 12th January 2021 for the period covering 1st October 2019 to 30th September 2020 it identified you were accepting 13 02 08 Waste oil, 16 06 01 lead acid batteries, 15 01 04 tin cans, 16 02 13 computer monitors and 17 02 01 wood waste, which are not an authorised waste type on your permit. The operator acknowledged that they have been using the incorrect EWC codes due to an administrative error.

After reviewing the waste return for January to March 2021 it appears that you are still accepting 15 01 04 tin cans, 16 02 13 monitors and 17 02 01 wood, which are not an authorised waste type on your permit.

Action -

In order to rectify this breach please consider whether you need to vary your permit or your operations with regard to EWC codes 15 01 04, 16 02 13 and 17 02 01.

In this document 'Natural Resources Wales' means the Natural Resources Body for Wales established by Article 3 of the Natural Resources Body for Wales (Establishment) order 2012.
