4. Details of our assessment

A final surrender visit was conducted at Browns Waste Management and Recycling Ltd permitted site EPR/NB3697TD on 10 June 2021 by Sally Wakeford and Michael Edwards. We were accompanied on site by Mathew Roderick of Browns Waste Management.

All waste had been removed from the site, the building was empty and the yard clear of any waste and debris. A small amount of hardcore had been used at the site under a U1 exemption for the hardstanding.

There is still a requirement for the operator to clean the sump to ensure no liquid remains. The operator began the action to undertake this whilst officers were still on site.

Following the site inspection and review of Compliance reports I can confirm that this could be considered for a low risk surrender, as per my previous email.
