Attended site on 8/4/21 due to incident report (WIRS 2102889). Rag embedded in bank

either side of spillway. Screen was confirmed not to be functioning as intended via email. This is a breach of Condition 5 which states 'The effluent shall be passed through a screen of 6 mm aperture size prior to the discharge. All screenings shall either be returned to the downstream sewer or collected and disposed of off site'.

Actions are required by 16/7/21.
