4. Details of our assessment

Inspection Meadowbank Poultry Unit Permit EPR/YP3637MJ

This report details the site visit made on the 17 June 2021 to Meadowbank Poultry Unit. EPR/YP3637MJ

Tony BRUTEN and Peter JONES attended at the unit and met with the site manager Andrew.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the people/property/environment
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

The inspection centred around the BAT conclusion replies submitted to Natural Resources Wales earlier in 2021 as a permit requirement. There were no issues with these and the BAT techniques being carried out were approved.

A second part of the inspection included checking on site drainage. This is covered under

- **b) Infrastructure** and b3 refers to site drainage and engineering (Clean and foul).

There were two areas of concern with onsite drainage.

- The first being near the main entrance to the Unit and dirty water from underground storage tanks pooling on the concrete surface. This was then over spilling into an adjacent field where it was causing contamination. In this adjacent field there had been a ditch excavated to catch water over spilling from the poultry site. This would be acceptable if it was only clean surface water but not contaminated water as was occurring. There was evidence in the ditch of dirty water deposits and this ditch needs to be cleaned out and repairs carried out to the surrounding site breeze block layer to ensure containment of dirty water
- Secondly at the rear of the site where there had originally been a pond as indicated on the site plans there is now a ditch receiving what should be just clean water runoff from the site. This ditch again is full of contaminated water and there is evidence of this nutrient contaminated water running off site and down the adjoining field. This ditch needs to be cleaned out and work completed to ensure only clean surface water enters this ditch.

Photographs were obtained at the time and have been attached to the Compliance Assessment Report (CAR).

All ditches must be cleaned out and the breeze block wall at the front of the unit repaired as well as improvement to the on site drainage to ensure only clean surface water enters the ditch at the rear of the unit once that ditch has been cleared. All work to be completed by 30th September 2021.
