This was a routine unannounced site inspection to the site by the new Natural Resources Wales (NRW) regulating officer Environment Officer (EO) Paul Challender who was accompanied by EO Callum Brannan. The weather conditions during the inspection were cold, still and partially overcast. During the inspection the NRW officers were assisted by Mr Marcin Pietrzak.

Prior to entering the site sections of the perimeter fence were inspected. This external inspection, at the time it was conducted raised no concerns regarding security infrastructure, emissions of waste or excessive noise from the permitted site.

During the inspection the site was operational with operatives in the yard processing waste metal. All appeared to be correct in the yard area. The external yard area, although very full of metal waste appeared to contain only permitted waste types.



Mr Pietrzak was manning the office at the time of the inspection and was able to furnish the inspecting officers with all requested paperwork. This included a selection of Waste Transfer Notes which appeared to be in good order, Technically Competent Management (TCM) certification and evidence of TCM attendance and also the Site Diary which appeared to be being utilise to record pertinent information and unusual event at the permitted site.

Enquiries were made with Mr Pietrzak about the future of the site and if the removal of metal waste from the Gwespyr site is under way as there is was proposal to move all operations to move all operations to the Delyn Metals Point of Ayr facility. Mr Pietrzak stated that the Gwespyr site was not currently being destocked and that it was unknown if and when the Point of Ayr facility would receive all wastes for the company.
