4. Details of our assessment

Thank you for the information received on 16th April, 2021, which included 2 no. Rambol Reports dated 17th March, 2021, both relating to the round 33 borehole monitoring for the Site Protection and Monitoring Programme (SPMP).

NRW has considered the contents of the reports and make the following comments:

1. With regards to the groundwater monitoring for the site and as concentrations have stabilised, NRW accept the recommendation for the sampling frequency to be reduced from 6 monthly to annually. In the unlikely event that contamination increases, NRW reserve the right to revert to twice yearly monitoring. **Action 1: The next round 34 sampling for the SPMP shall be carried out by 16th February, 2022 and the necessary reports submitted to NRW within 2 months of the completion of the sampling.**
2. NRW agree with the replacement of MW1 and MW2 at locations close to the existing boreholes to allow consistent monitoring over time. Please continue to include the borehole logs within the next sampling round 34.
3. Thank you for including the water levels in mAOD as well as in mbgl. There is now enough data (over 15 years' worth of data) to draw up hydrographs and contour plots for the site to confirm groundwater flow directions, this would have to be done to mAOD. NRW recommends this approach is considered when the next round of sampling is carried out.
4. With regards to BHS6 and MW2A, NRW notes the retesting action plan for exceeding trigger levels at these locations. Whilst the action plan is agreed in principle by NRW, it is recommended that it be updated to ensure any resampling is carried out within 1 month from the date of the trigger level being first observed and a report of findings submitted to NRW within one month of the report being produced.
