4. Details of our assessment

Tony Bruten accompanied by Peter Jones carried out a sit inspection on Monday 28th June 2021. They met with the owner/operator Robert Parker.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 1 - Major, serious persistent and/or extensive impact on the people/property/environment
- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
- 4 - A non-compliance which has no potential environmental effect

On this occasion NRW did not identify any issues that require a breach of permit conditions. However we did notice that there were some nutrient deposits into the drain pond at the rear of the premises which holds the clean water runoff from the site as it soaks away which if not addressed could cause pollution.

The pond water appeared dark and there were signs of the clean water having been contaminated prior to entering the pond.

Further investigation identified a possible source of the contamination as dust beneath four of the fan outlets on the shed nearest to the pond.

Rob Parker agreed that he would put a solid surface beneath each extractor fan so that the feed dust could be easily cleaned up to prevent contamination and clean out the pond to ensure only clean water is collected in the pond. There was no evidence of any pollution to watercourses and so with the improvements agreed this will minimise any future chance of pollution.

This work should be carried out and completed before 30th September 2021.
