4. Details of our assessment

The site inspection of Coombe Farm Poultry Unit was carried out by Tony Bruten and Peter Jones on Monday 5th July 2021.

The inspection consisted of a walk of the site yard and perimeter and inspection of site drainage. There then followed an inspection of site records to ensure compliance with details listed in BAT Conclusion Returns submitted in March 2021.

There were no breaches identified during the inspection and the site was in excellent condition.

To remind the operator, following each assessment Natural Resources Wales will produce a Compliance Assessment Report (CAR) detailing our comments from the audit. If we substantiate reasonably foreseeable risks or actual impact to the environment, we can breach the business against your permit conditions. This can affect your site banding and annual subsistence fees; scored on a Category 1 - 4 basis:

- 2 - Significant impact or effect on the environment/people/property
- 3 - Minor impact or effect on the environment/people/property
