Environment officer Laoni Tye visited site and met with site TCM Gareth Danter-Hill. Tom Prichard (Director) and Stuart Richards (site manager) accompanied us on the visit. The weather was mild and damp at the time of the visit and it had been raining previously. It was a planned, announced visit to conduct a general inspection. There were a couple of breaches recorded:

B3 – Site drainage engineering (Clean and foul). Category 3 breach.

Condition 2.1.1 states that the operator is only authorised to carry out the activities specified in schedule 1 Table S1.1....

A2 – Open Windrow composting –states that all waste must be stored and treated on an impermeable surface with sealed drainage.

The area which served the composting facility is supported by an impermeable surface but at the time of the visit, it was not a sealed system. The area of concrete was not properly bunded and sloped down to an area of hardstanding. A temporary bund had been constructed out of soil, stone, mud but this does not constitute an impermeable surface with sealed drainage system and there is therefore a pathway for leachate/run off to impact on groundwater.

****Action to rectify this issue was taken following the visit and a concrete bund was constructed to bring the site back into compliance with this condition. Photographs of this were provided via email on the 20th June 2018****

F1 – Amenity – Odour. Category 4 impact.

Condition 3.2.1 states that Emissions from the activities shall be free from odour at levels likely to cause pollution outside the site, as perceived by an authorised officer of Natural Resources Wales.....

When arriving onto the civic amenity site which is situated directly adjacent to LRC there was a strong odour of compost. It was agreed that this odour was strong and that the composting process may require improvements. We were told that this however was unusual and that the site had not had any complaints.

The leachate was still being added to the compost at this time which may have been attributing to the mal odours. There had been no shredding or trommelling at that time of the visit. We discussed an additional visit would be beneficial with our bio waste lead to look at the process.

This has been scored as a category 4 breach as although there was an odour off site and it is likely that this could go further and affect receptors, we are not aware that it was impacting anyone at the time, there were no complaints received. A record of the breach however is required and is something that will need to be closely monitored.
