4. Details of our assessment

Officer Magda Leonowicz and David Warwick-Brown attended Neal Soil Suppliers Limited at Longships Road, Cardiff Docks, Cardiff, CF10 4LU on Thursday 24/06/2021 at 10:40 to carry out a routine inspection of permit EPR-UP3396EK and to introduce Magda as a new compliance officer. The weather conditions were warm and dry at the time of visit. Both business TCM John Edwards and Gavin Powell were present during the visit.

The stockpile with vegetation growing on it was present at the site as noted during the previous site inspection on 17/09/2019. There were other stockpiles present which were brought to the site more recently. See pictures attached. Only inert waste is being stored on the sites. Excavator was present and operating. The waste was being taken away to operator's another site for processing.

The operator confirmed that they are planning to make an application to surrender their permit in due course. No issues were noticed at the site. Numerous photos were taken during the visit.
