A desk based compliance audit was undertaken for the mobile plant permit, EPR/PB3690HD, which is a standard rules mobile plant permit for landspreading - reference SR2010No4

C1 Staff competency

Permit condition 1.1.4 requires that *"the operator shall comply with the requirements of an approved competence scheme"*. Our records show that Luke England holds the correct WAMITAB qualification for the permit, and has an up to date continuing competency qualification which lapses in November 2018.

C2 Management system and operating procedures - Action only

Permit condition 1.1.1 of the permit requires that you *"manage and operate activities in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attend of the operator as a result of complaints"*. We cannot find an Environment Management System (EMS) on our records for the mobile plant activities.

Action: please submit the EMS for the mobile plant permit by 27th September 2018

G4 Reporting and notification - C4 breach

Permit condition 4.2.2 requires the submission of waste returns within one month of the end of each quarter. Waste returns are missing for quarter 3 2017 (July - September 2017) and quarter 2 2018 (April - June 2018). A category 4 breach has been given for these missing submissions.

In addition, waste returns submitted for quarter 1 2018 (January - March) document that you removed a variety of waste codes from deployments during the quarter, which are not listed under the permit.

Action: submit waste returns for the missing quarters, and provide an explanation for the removal of wastes under the permit in quarter 1 2018, by 27th September 2018.
