This CAR form is generated following a video of pollution in the local area which was posted on twitter, and a self-report by DCWW.

After DCWW's self-report NRW requested data from DCWW for the storm discharge, which was duly provided. The spill data was compared to NRW's rain gauge information, both data sets depict discharge which coincides with a rain fall event.

NRW are requesting that DCWW carry out a review of the incident (if not already done) and from this review NRW are requesting that any learning/preventative objective to prevent

further incident, be shared when complete.
