4. Details of our assessment

This was a routine unannounced inspection visit by regulating officer Elis Nuttall. At the time of the inspection the weather was dry and clear. During the inspection the officer was accompanied by site operator Will Chipchase.

During the visit the officer was given a tour of the site by Mr Chipchase.

It was observed within the battery storage area that small domestic batteries were stored within covered containers, but large car batteries were sitting out in the open. It was explained that the site has had issues with theft of car batteries from and as a result any car batteries left at the site are stored within a weatherproof and lockable container overnight. While this may resolve the theft issue it is a requirement to store these batteries at all times in an appropriate container. It was noted that the operators have asked the council for an appropriate container. Please could this be prioritised and resolved as soon as practical.



One of the oil drums used to store oil filters was contaminated with aerosols. This was highlighted by the site operators and advised that appropriate disposal will be organised for this contaminated waste.



The site was in very good order overall with staff working effectively to assist the public in disposing of waste in the correct containers. The site was very tidy with no visible waste

items having escaped the appropriate storage areas. Please ensure this good practice is continued in future.

The following breaches to the permit have been recorded:

No breaches noted for this inspection.

Actions Required:

1. Please make appropriate arrangements for a container to be provided for the storage of large car batteries on site. This can be placed within a lockable storage container if issues with theft continues.
2. Please dispose of the contaminated waste appropriately as soon as practical.
