4. Details of our assessment

As a part of Natural Resources Wales' (NRW) routine assessments for compliance the waste returns for Gwrthwynt were reviewed.

G4 Reporting and notification to Natural Resources Wales – Cat 3

During the review of the waste returns for the period covering 1st July 2019 to 30th June 2020 on the 8th January 2021 it was noted that the description for SDAs and LDAs were incorrect. Due to this, the action required was to submit waste returns with the correct description for SDAs and LDAs by 31/03/21. Although this action was not completed by the expected deadline, the officer realised that it was not made clear that the requirement was to re submit the returns for the period with the correct description. Due to this, the deadline was extended to 04/06/2021 and this action has completed.

Thank you for resubmitting the returns as requested. After reviewing, it appears that you haven't taken the advice from the previous CAR form about how to correctly code your domestic appliance waste. SDA's discarded electrical equipment is still coded as the 20 01 35 and the LDA's discarded electrical equipment is still coded as 20 01 36. As I set out in the previous CAR form dated the 08/01/21, NRW would expect to see the description for 20 01 35 being SDA hazardous discarded electricals or LDA hazardous discarded electricals and the same for 20 01 36 the SDAs/LDAs non-hazardous discarded electricals.

Please ensure that you follow the WM3 guidance which can be found [here](#), to ensure that wastes are coded and described correctly, especially with regards to hazardous wastes. To be done with immediate effect.
