### 4. Details of our assessment

**To be read in conjunction with CAR\_NRW0037382 which is the audit of the discharge permit at the site.**

This was a pre-planned OSM audit carried out by Natural Resources Wales officers Emma Sharp

and Jeremy Goddard, who were accompanied by Dŵr Cymru Welsh Water staff Michael Jones and Sarah Mowlam.

The site has an active storm discharge permit (BP0361401) which was issued on 20/03/2007. The discharge point for final effluent and storm into the receiving watercourse was visually checked. There were no obvious signs of pollution and the discharge looked clear. There is no storm tank on site, therefore discharge goes directly into the Nant Medini.

Following the visit, a request was made to Dŵr Cymru for monitoring data associated with Beulah STW covering the period from 21/08/2019 to 21/08/2020.

There is an EDM at the storm outlet, however it is not currently being reported from. DCWW have informed us that data has been available since 08/01/2020. This will be reviewed and investigated further and provided to NRW as soon as possible.

**ACTION: Please provide EDM storm data once it has been reviewed and investigated.**

On 28/05/2021 NRW received an email from Sarah Mowlam (DCWW) providing EDM storm data for this asset. All spills between 08/01/2020 and 15/08/2020 were within permit compliance. Therefore this is no longer listed as an action in the report.
