### 4. Details of our assessment

No odour was detected on site during the inspection, or during an offsite odour assessment completed immediately afterwards. This offsite odour assessment included the following areas: New Hall Road, Vauxhall industrial estate, Heol estate and Bangor Road.

Following the site inspection, the operator provided NRW with updates on the progress of the capping works and installation of new gas wells.

The operator has permanently capped an area of 9647m<sup>2</sup> with engineering clay from the site and plans to carry out further capping at the end of summer, once the western area is up to final levels.

The operator has completed the installation of 21 new deep gas wells covering Cells 1,2,3 and 4.
