4. Details of our assessment

Compliance assessment January – June 2021

Environmental permit EPR/UP3831ES, Condition 2.2.1.3, Table 2.2.2 Emission limits to air.

On 21 April 2021 a formaldehyde exceedance from emission point A18 to air of 3.9 versus 2 mg/m³ limit was identified during routine annual testing by an MCerts accredited company.

The emissions are subject to scrubbing and catalytic oxidation prior to discharge to atmosphere through a 15 m stack.

The scrubber A504 has been inspected, cleaned (packing in good condition, found to be operating normally) and refilled with caustic solution to enhance performance.

The catalytic oxidiser carbon monoxide monitor has been recalibrated though no increase (result lower than previous year) and the pressure drop across the catalyst bed was found to be normal (phenol was below detectable limits and methanol at half of limit). The catalyst is not due for replacement but under review.

A compliance score of CCS3 is considered appropriate.
