4. Details of our assessment

Natural Resources Wales Waste Regulation Team (NE) were recently made aware that Roadway Civil Engineering & Surfacing Ltd was acquired by Breedon Trading Limited in October 2019. Advice has now been sought by the company with regard to transferring the permit **EPR/NB3293HV** and an application is due to be submitted. As Natural Resources Wales were not made aware of this change within the 14 day period specified by the permit, this has generated a compliance score for breach of permit conditions. This is detailed further below;

Category 4 compliance score - breach of permit condition 4.3.4

Section 4.3.4 of the permit states;

4.3.4 Natural Resources Wales shall be notified within 14 days of the occurrence of the following matters except where such disclosure is prohibited by Stock Exchange rules:

a) Where the operator is a registered company:

any change in the operator's trading name, registered name or registered office address; and

any steps taken with a view to the operator going into administration, entering into a company voluntary arrangement or being wound up.

b) Where the operator is a corporate body other than a registered company:

any change in the operator's name or address; and

any steps taken with a view to the dissolution of the operator.

c) In any other case:

the death of any of the named operators (where the operator consists of more than one named individual);

any change in the operator's name(s) or address(es); and

any steps taken with a view to the operator, or any one of them, going into bankruptcy, entering into a composition or arrangement with creditors, or, in the case them being in a partnership, dissolving the

The purchase of the company Roadway Civil Engineering & Surfacing Ltd by Breedon Trading Limited occurred in October 2019, however Natural Resources Wales were not notified until September 2020 when an email was sent to our Business Support Team. On the 15/07/2021 site TCM Matthew Davison confirmed to New Regulating Officer, Amy Henderson that staffing/TCM and operations under the permit had stayed the same.

This has generated a category 4 compliance score for a breach of the above permit condition.
