We are currently considering taking enforcement action against you for the non-compliance recorded above. We will contact you in due course.

4. Details of our assessment

A review of waste returns was carried out in relation to permit **EPR/TB3590HJ** for the period Quarter 1, 2, 3 & 4 of 2020. The site is permitted to accept 100,000tonnes per annum. Waste returns submitted for this period state the following quantities were accepted

during each quarter.

Q1 - 6839.6 tonnes

Q2 - 49920.6 tonnes

Q3 - 49920.62 tonnes

Q4 - 54337.6 tonnes

Total quantity accepted - 161,018.42 tonnes

Condition 1.2.2 of the permit states;

The total quantity of waste accepted at the site per year shall not exceed 100,000tonnes.

The returns submitted show a total of 161,018.42tonnes were accepted under the permit during 2020. This quantity exceeds the permitted allowance by 61,018.42 tonnes.

Permit conditions are put in place to protect the environment and people in the locality. The permit is determined based on these conditions and the quantities are limited to manage this risk. The waste returns show this quantity was exceeded by over 60% of the permitted limit. The quantities for the year had already been exceeded before Q4, yet during this period a further 54337.6tonnes were accepted. Correct management of the site should have prevented a breach of this nature.

An over acceptance of this quantity is a significant breach of permit conditions and has therefore generated a category 2 compliance score under condition 1.2.2 of the permit; The total quantity of waste accepted at the site per year shall not exceed 100,000tonnes.

Enforcement action is being considered.
