4. Details of our assessment

An inspection was carried out at AMG Resources Ltd permitted facility, permit number EPR/BB3793ND, on 26/07/2021 by Sally Wakeford, accompanied on site by Adrian Stewart and Mark from South Wales Pest Experts.

The large amount of waste at the rear of the site had been removed from site, and the area was clean and tidy.

More baled cans had been brought to site, and these were stacked in small piles and remained baled.

There were a number of piles of loose can wastes at the two baler locations, however this amounted to approximately a day or so of baling.

Some fly activity was observed on these piles of waste, but much reduced from previous inspections.

Daily fly control spraying and monitoring will remain in place until the new baler is up and running.

The fly sheets, which are changed on Fridays, showed very little housefly activity, although contained an amount of fruit fly. At present the site have been unable to identify where the fruit fly are coming from, they were not visibly present on the can wastes.

No breaches of permit were noted during the inspection. Ongoing action to update Pest Management Plan has been noted again on this inspection report.
