This was a routine site inspection by Natural Resources Wales (NRW) environment officers Kim Jones and Callum Stone.

We met with the site manager, Alun Hughes and briefly discussed the findings of the previous visit and then walked around the site.

This is a small inert waste transfer station that is not open to the public. There is a clearly marked area for depositing the incoming waste. It is at this location that Alun has the opportunity to remove any unsuitable waste material which is then transferred to the quarantine area for disposal off site.

A mobile crusher is hired when needed and the resultant material is used as general fill for building projects.

The permit breaches observed are:-

### **CAR Sub criteria G4, Permit condition 4.2.2 Compliance Classification Scheme category 4 breach.**

No waste returns have been submitted for 2018. Mr Hughes submitted last years returns but was advised that volumes were needed and not just the number of loads. The site does not have a weighbridge so he was advised to make a best estimate of the volume that had been deposited. The volume could be recorded on the waste transfer note or in the diary. It was agreed the returns would be provided by 31st Oct 2018. There is no potential environmental effect for not providing the waste returns so this has been given C4 score on this occasion.

### **CAR Sub criteria G2, Permit condition 4.1.1 Compliance Classification Scheme category 4 breach.**

Waste deposited at the site and removed from the site has been recorded as loads and not the actual volume. The permit allows 75,000 tonnes a year to be accepted at the site. Without recording the volume being deposited there is no record of the volume being accepted at the site. The site manager has the waste transfer notes so there is no risk that the site has been in exceedance of the permitted volumes and the size of the site is also a limiting factor therefore the breach is scored as C4 as there is no environmental effect.

The two breaches give a score of 0.2
