The following non-conformance has been reported to Natural Resources Wales following the Pig and Poultry Assurance Scheme inspection at Dumbles Poultry Farm on the 29-07-21 –

No litter analysis in the last 6 months recorded.

You have been given a breach under the above conditions because during the assurance scheme inspection it was noted this information was unavailable which is a requirement of your permit.
