Since June 2016, Natural Resources Wales have agreed with Moto Hospitality Limited to suspend further water quality compliance breaches whilst further investigations have completed to identify and resolve root cause and failures with the treatment plant serving Cardiff West Services. As part of that agreement Moto agreed to routinely sample both the influent and final effluent, as well as implement an improvement plan with several option including plant upgrading or replacement in order to bring the final effluent water quality back in to compliance.

Since the initial agreement, Moto have committed in excess of £400k of investment including installing two SAF units (T300 and T1000), an auto-sampler, balancing tank conversion, chemical dosing along with continued consultancy fees and have remained committed to bringing the treatment plant and EPR licence back into compliance.
