Annual monitoring and reporting requirements review with reference to permit FP3031CW issued 27 Sept 2013 were assessed for submissions to air and covers the period 2014 to 2020.

Monitoring for all emission points and parameters required by condition 3.5.1 was undertaken and the results reported within the timescales required by condition 4.2.3 of the permit.

Monitoring of emissions to air were submitted 2014 to 2020 as required and results for the emission point(s) were within the emission limit values specified by condition 3.1.2.
