4. Details of our assessment

Please note: Due to internal and external ICT issues, Natural Resources Wales were unable to issue this CAR form via the Compliance Assessment Recording System. This has now been resolved.

Liz Park arrived at Dan Y Parc Depot to undertake an announced visit. At the time of the inspection it had been raining. Liz met with Chris Richards.

Chris showed Liz all the management system documentation. Whilst this was not fully assessed on site, it all appeared to be up to date and complete.

One dewatering bay contained street sweepings. The other bay contained inert/ tarmac waste that was being temporarily stored under the Waste Exemption: Non-Waste Framework Directive 3 temporary storage of waste at a place controlled by the producer. Chris said that this waste was going to be removed in the next few days and would ensure that it is not mixed with the street sweepings.

No non-compliances were found. The site was clean and tidy.

The oil storage tank was checked due to a recent oil pollution incident. No issue was found.
