## 4. Details of our assessment

### **Solutia UK Limited**

Annual monitoring and reporting requirements review with reference to consolidated permit NP3335GR variation 008 issued 23 June 2015 following closure and demolition of the Ruabon site were assessed for submissions relating to untreated / activated carbon treated groundwater and discharges to surface water and covers the period 2016 to 2020.

Monitoring for all emission points and parameters required by condition 3.5.1 was undertaken and the results reported within the timescales required by condition 4.2.3 of the permit.

Monitoring of emissions to surface water were submitted 2016 to 2020 as required and results for the emission points were within the emission limit values specified by condition 3.1.2.
