4. Details of our assessment

Evaluation of Ambient Bioaerosols at Llanddulas Composting Facility

Bioaerosol monitoring was undertaken in accordance with Condition 3.4.1(b) on 11 June 2021 and submitted in accordance with Table S4.1 on 24 June 2021.

Table S3.2 specifies limits for bio-aerosol concentrations as follows:

- Total bacteria (TB) - 1000 cfu/m³
- Aspergillus fumigatus (AF) - 500 cfu/m³

Bioaerosol concentrations were below the above limits at all sampling locations during this monitoring exercise.
