Permit condition 1.1.1 of the permit requires that you "*manage and operate activities in accordance with a written management system that identifies and minimises risks of pollution, including those arising from operations, maintenance, accidents, incidents, non-conformances, closure and those drawn to the attend of the operator as a result of complaints*".

The site has an integrated management system that is certified to ISO 9001, ISO 14001 and OHSAS 18001.

Permit condition 1.1.4 requires that "*the operator shall comply with the requirements of an approved competence scheme*".
