#### Breach of permit condition

**Compliance Classification Scheme breach for E3 (Emissions to water)** – the results from the final effluent sample taken on 02<sup>nd</sup> August 2018 breached your permit condition related to the sites emission limits.

The sample results were as follows

- Suspended solids 50.5 mg/l (permit requirement is 30 mg/l maximum)
- Bioavailable Oxygen Demand 40.6 mg/l (permit requirement is 20 mg/l maximum)

Therefore the sample taken on 5<sup>th</sup> December 2014 failed the suspended solids and Bioavailable Oxygen Demand emissions requirement.

#### Actions required by 31<sup>st</sup> August 2018:

- Investigate whether you had any operational issues around the time of the breach (2nd August 2018) that could have caused the poor quality effluent
- Confirm whether you have taken any remedial action.
