4. Details of our assessment

Tata provided a Schedule 1 Part A Notification to NRW dated 23rd June 2021 in respect of elevated oil levels detected at the W1 effluent release point. A value of 7.7mg/l had been recorded against the limit of 5mg/l. It was noted that there had been no visual reports of oil, the oil boom on the lagoon prior to W1 was in place and the oil alarm had not activated. Following further investigations a Schedule 1 Part B was provided on 14th July 2021. This

detailed further analytical data (the second sample taken was determined to have an oil content of 6.7mg/l). It was also noted that all drains into the main drainage channel had recorded above normal oil levels.

It is noted that the average of the two results (6.7mg/l and 7.7mg/l) is less than the permitted peak spot value of 1.5 the ELV. No other exceedances of the oil in water limit have been reported this calendar year. In view of the measures that Tata have in place, the absence of any subsequent raised oil in water levels and analysis uncertainty, in this instance NRW have not scored this incident as a non-compliance.
