NRW received Air1 form for Q2 of 2021. The plant has been shut down since April 2020 and prior to this they only had sporadic running and haven't had enough consecutive days on which to perform QAL2 and AST testing. They therefore cannot complete the Air\_2 form as of yet.

Air1 form covering April to June states zero values for each parameter which is inline with the plant being shutdown.

Waste Return Q2 April to June was received with zero values and accepted.
