4. Details of our assessment

This CAR form acknowledges receipt of data for the monitoring point source emissions to water at 'TSP1', 'TSP2' and 'SESP', for Quarters 1 and 2, 2021.

With regards to the TSP1 results for Q1, these were received on 19th February, 2021 along with a Schedule 5 Notice dated the same, for the exceedance of copper reported at 55ug/l against a maximum ELV of 40ug/l. NRW acknowledge the fact that an investigation was undertaken, and that Sims were unable to identify the root cause for the elevated result. The exceedance has resulted in a Category 4 score.

Q1 results for TSP 2 and SESP were received on 31st July, 2021 and both were within limits.

Action 1: As a reminder, Sims to ensure compliance with condition 4.2.3 of the permit by ensuring reports for the monitoring and assessment are submitted within 28 days of the end of the reporting period.

Q2 monitoring results for TSP1 could not be provided due to low flow on the date of sampling. Whilst NRW recognise that discharge from the site is rainfall dependent, it raises concerns that sampling of TSP1 was left until the last day of the quarter.

Action 2: In order to ensure that Sims discharge their responsibilities of gathering representative water quality data for each of the 4 quarters, Sims to follow their approved protocol by collecting spot samples from TSP 1 and TSP 2 either during or after rainfall events.
