A review of the Ruabon Landfill December 2018 data submission has taken place.

This data relates to the period of 01 December 2018 to 31 December 2018. The data was received via email on 24 January 2019.

December's gas monitoring results show the following readings for Methane;

5th December

RUBH0007 – 11.1%

RUGP00A2 – 3.5%

12th December

RUBH0007 – 13.7%

21st December

RUBH0007 – 16.6%

RUGP0001 – 2.6%

27th December

RUBH0007 – 16.7%

RUGBH001 – 3.5%

RUGP0001 – 2.3%

The following breaches have therefore been recorded.

(The requirements of the permit specify that monitoring is reported on a monthly basis, the breaches identified below will be consolidated with the breaches recorded on the previous Compliance Assessment Report (Ref CAR_NRW0034504) for the November data submission. This is because the breaches were within the same reporting quarter (Oct – Dec) and are recorded against the same permit conditions – therefore although detailed below, no additional Compliance Classification Scheme points have been recorded against the sites annual compliance score.)

Permit condition J.29 (Working plan I.27), Compliance Assessment Report Sub criteria G4, Compliance Classification Scheme Category 3 breach (Score consolidated)

Permit Condition J.29 and subsequently Working Plan condition I.27 requires the operator to inform the regulatory authority of any readings which exceed 1% of flammable gas immediately, and to confirm in writing within 7 days. This condition has not been met.

Permit condition J.29 (Working plan I.27), Compliance Assessment Report Sub criteria C2, Compliance Classification Scheme Category 3 breach (Score consolidated).

Permit Condition J.29 and subsequently Working Plan condition I.27 outlines that the cause of any flammable gas greater than 1% or carbon dioxide above agreed trigger levels will be investigated and suitable improvements or additional measures will be undertaken at the earliest practicable time to ensure such gas levels are reduced below those indicated. This work has not been undertaken despite elevated readings.

It is to be noted that the readings in excess of 10% Methane in all 4 weekly samples at RUBH0007 are of particular concern.

As outlined within the previous Compliance Assessment Report (Ref CAR_NRW0034504) for the November 2018

monitoring submission, Our files indicate that the Working Plan has not been amended since 2001. This plan does not represent the current status of the site, and does not adequately cover the actions to be taken in the event of elevated gas levels recorded in perimeter boreholes.

The actions outlined within the previous Compliance Assessment Report still remain
