4. Details of our assessment

This Compliance Assessment Report is in relation to a site inspection carried out on the 14th June 2021.

Thank you for your time during the recent site inspection. During the visit I visited the main

building, casting building, and de-odouriser plant. I was also shown the main penstock valves and drainage system, the waste yard and WWTP. It was beneficial to see the processes on site and the emission points as set out in your permit. At the time of the visit I did not note any concerns in terms of noise, vibration, or odour coming from site. The site was well maintained and good practices in terms of house keeping were noted.

New Melt Furnaces:

It was useful to see the location of the new melt furnaces and the measures in place to ensure a smooth transition during the replacement process.

Action: The replacement of the melt furnaces has been agreed by NRW under an 'exchange of letter' instead of a formal variation to your permit due to no changes made to emissions or location of equipment. NRW are still awaiting this report so that an exchange of letter can formally be processed. Please can you confirm when this report will be ready for submission to NRW.

Could you also notify me once the melt furnaces have been replaced and are operational.

Potential DAA/Permit variation:

We had a discussion with regards the potential use of waste gas via linked pipework from a new site which is looking to operate close to you. I recommended at the time of the visit that any potential linked site or pipework may need to be included in your permit either as a Directly Associated Activity, an amendment to your site boundary or other depending on the final design. I would recommend that when a decision is made regarding this, that a meeting is arranged with NRW to discuss how this may impact your current permit and conditions.
