### 4. Details of our assessment

Environment Officer Robert Andrews, Natalie Wrangham and Biodiversity Officer Michael Launder visited the

site to inspect the abstraction and discharge permits. The weather was damp and warm at the time of inspection.

They were met on site by site operator, Thomas Hawkes and his colleague (Both Severn Trent).

Thank you for taking the time to show us around the site and explain your activities. In general, the site appeared well managed and both operators were very knowledgeable and competent. There was only one minor breach and an observation recorded on site.

Received the spreadsheet and information from Cara Callingham on 9th August 2021. All readings were in the permit requirements.

#### 4.0 SAMPLE POINT

***The outlet to controlled waters shall be constructed, maintained and appropriately labelled so that a representative sample of the discharge may be obtained.***

Action: Install signage at the designated discharge area. This should be carried out by the **01/10/2021**.

### **(WQ-A1) General management (Action only)**

#### 8.0 MAINTENANCE

***The treatment facility shall be operated and maintained in accordance with good operational practice.***

Action: Remove any waste (sludge etc) from high risk areas that can cause contamination and pollution run-off. This is an ongoing issue and is only an action point. This should be carried out by the **01/01/2022**.
