Weekly monitoring for May received and reviewed.

G/W monitoring data provided for May. The permit states that you should be monitoring BH 202, 205, 204, 208, 211, 210. But in this latest round you have monitored BH 202, 205, 204, 210 only and added another that is not on the permit 206, so 208 and 211 are missing.

This matter has been highlighted to the company via email and is currently being rectified.
