4. Details of our assessment

Officers Loku Ranasinghe and Magda Leonowicz attended site for a final site inspection, as we had become aware that the Surrender application has been submitted. Mr. Lee Bremner showed us around the site. Mr. Bremner had informed us that the site had been handed over to the owners and he had to arrange to collect the keys to show us around.

All The site appeared to be clear in all the previously operational areas. We did not observe any potentially polluting material from operations left within the site boundary. While we noted a couple of drums on site, these were empty. We also advised that Mr. Bremner would be eligible for a rebate on the annual subsistence fee from the point the surrender was approved and that he should contact Permitting Enquiries regarding this.

Queried regarding the covered area and Mr. Bremner explained that these were from the repair pits when the buildings used to be air craft hangars. He confirmed that no liquids have been stored in this area and CAR forms from previous visits do not indicate anything to the contrary.





We noted the water pooling in the yard and Mr. Bremner explained that this was due to the ongoing drainage issues at Llandow Industrial Estate, as we had witnessed previously and had been explained to us on previous visits. We have no reason to believe that this is in any way connected to the operations of JWB.
