Any non-compliance we have identified and recorded on this form is an offence. It can result in criminal prosecution and/or suspension or revocation of your permit.

4. Details of our assessment

A site inspection was undertaken on 10 August 2021 by Sally Wakeford at Morris & Co (Handlers) Ltd permit number EPR/BB3394CL, accompanied on site by Tom Morris, Vicki Cooper, Joanne Mcanulty and Martin George of Morris Metals.

The visit was requested by the site as they wish to vary their permit to increase throughput. This will require a variation to an Installations permit as the throughput is limited in the permit by the Industrial Emissions Directive.

The new building is completed, with concrete floor draining to the rear of the building, similar to the existing building on site. This new building is for the storage of incinerator waste coming into the site and the processed incinerator waste going out of the site. This building is 57.4m x 18.8m x 5m high – 5,395.6m³.

As the new building is completed and being used for the waste operation, the Environment Management System and Fire Prevention and Management Plan will require updating to ensure they reflect the current operations on site. One completed please provide a copy to Natural Resources Wales. I understand that these documents are in the process of being prepared for the variation of the permit.

The site was well managed, clean and organised, with the different wastes segregated well. There was a small amount of beverage can waste on the site, stored well within the FPMP guidance limits for metal wastes.

We discussed extending the stockpiles of the incinerator scrap to be longer than the guidance allows. Due to the nature of the waste it presents a negligible fire risk. I will discuss this with you further under separate cover.

The measures for capturing of any fire water were discussed, a valve is to be placed on the drains in the yard capturing the surface and roof water, and closed in the event of a fire. The fire water would then be contained at the lowest point in the yard, once drainage is closed off, in the car park area. The water would then be tankered away.

No compliance issues were noted on site. The performance rating of the 2019-2020 year will remain in place for the remainder for the financial year, due to the way the compliance system works. However, if Morris & Co continue to operate the site in the manner noted during this inspection, the site will return to an A performer in the following compliance year (from April 2022).

I was pleased to see how well the site was being managed.
