

# Natural Resources Wales permitting decisions

## Bespoke permit

We have decided to grant the permit for Pencaedrain Farm operated by Staycation Cymru-Cyf.

The application number is PAN-014499

The permit number is EPR-CB3293FL

Pencaedrain Farm is a new glamping site located within Pontneddfechan. There are ten glamping pods in total, each one accommodating three people. Within each pod is a shower, toilet and wash hand basin. The permit allows a discharge of 4.5m<sup>3</sup> day from a British Standards package plant which enters a tributary of the Afon Sychryd.

We consider in reaching that decision we have taken into account all relevant considerations and legal requirements and that the permit will ensure that the appropriate level of environmental protection is provided.

## Purpose of this document

- shows how all relevant factors have been taken into account
- justifies the specific conditions in the permit other than those in our generic permit template.
