Officer James MALATYNSKI attended, Energy Pyrolysis on Friday 7th September 2018 at 12:30. A visit was to conduct a routine site inspection. The weather was fair and dry at the time of inspection.

Inspection

The site was closed and there was no access into the building where Energy Pyrolysis normally operate, there was no activity on site and the warehouse was secured with padlocks suggesting that there was no operation from site. There was no visible waste outside of the warehouse and the area was clear.

After speaking to neighbours of the site, I was informed that the site had been non-operational for approximately 9 months and there hadn't been any activity on the site in this time.

Waste Returns

NRW have not received waste returns submission for Q3 and Q4 of 2017 or Q1 and Q2 of 2018. It is reminded to the operator that waste returns should be submitted. For periods of non-operation or when no waste is received/removed on site, a nil return should still be submitted. Waste returns will need to be submitted until a surrender application is completed.

Action: Please ensure that up to date waste returns are submitted for Q3/Q4 of 2017 and Q1/Q2 of 2018.

Permit Surrender

A surrender application should be submitted to NRW given that the site is non-operational. It is reminded to the operator on site that subsistence fees will still need to be paid until a surrender application is submitted.

To surrender a permit an application needs to be made either online or via post. You will need to complete parts A, E2, F1 and CC1 from the link below:

You will also need to complete a H5 Site Condition Report which must be submitted with the application. Guidance on what should be included, and a template can be found at the link below. You will need to demonstrate how the activities on site have not caused any contamination throughout the lifetime of the site.
