4. Details of our assessment

Kronospan Limited

Annual monitoring and reporting requirements reference permit BW9999IG variation 007 include three thermal oil heaters, two gas turbines and five gas engines issued 30 November 2017 were assessed for submissions relating to air and surface water and covers the period 2018 to 2020.

Monitoring for all emission points and parameters required by condition 3.5.1 was undertaken (except non-operational combustion plant) and the results reported within the timescales required by condition 4.2.3 of the permit.

The emission limit value for emission point to air, A16 for K1 oil heater (a small combustion unit), was set at 90 mg/m³ for oxides of nitrogen in the permit issued in 2017. This has subsequently been identified as an error and agreed that the emission limit value should be taken as 200 mg/m³ (in line with emission points A17 and A18). It is proposed to update this as part of the current permit variation determination.

Monitoring of emissions to air and surface water were submitted 2018 to 2020 as required and results for the emission points were within the emission limit values specified by condition 3.1.2, with due consideration of the comments above.
